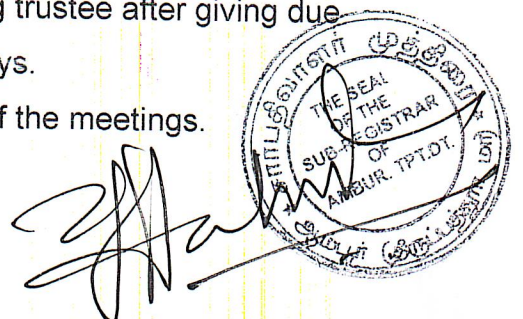


2. It shall be lawful for the board of trustee to frame rules and regulation for the conduct and managements of the trust.

#### MEETING OF THE BOARD OF TRUSTEES

- b. The trust shall apply for the registration with the director of income tax (exemption as a nonprofit and charitable organization).

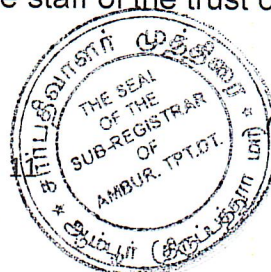
AMENDMENTS:
